**SUBJECT: ENGAGEMENT OF CONSULTANT (FINANCE & ACCOUNTS) AND BUSINESS DEVELOPMENT MANAGER (FINANCE & ACCOUNTS) (ON CONTRACT) IN APEDA, NEW DELHI.**

1. The Agricultural and Processed Food Products Export Development Authority (APEDA), an autonomous organization under the Department of Commerce, Ministry of Commerce & Industry, Govt. of India is mandated with the responsibility for promotion of agricultural and processed food products from India. APEDA has been actively involved in agricultural trade facilitation and intends to improve market access for Indian agricultural products at international level. The role involves managing brand support, analyzing market trends, developing marketing strategies, publicity and media relations, digital marketing and social media, coordinating with the creative team, and overseeing brand collaborations. APEDA intends to hire talented, innovative and dynamic Professionals for the positions of Consultant (Finance & Accounts) and Business Development Manager (Finance & Accounts) on contract basis.

**2. Type and Tenure of Engagement**

- (i) The engagement shall be at the level of Consultant (Finance & Accounts) and Business Development Manager (Finance & Accounts).
- (ii) The engagement shall be purely on a contractual basis.
- (iii) The engagement shall be initially for a period of one year including probation period of three weeks. The tenure of engagement may be extended on a year to year basis, depending on the performance evaluation. After three years no further extension will be permissible under any circumstances.
- (iv) **Qualification, Experience and Vacancies:** Applicants with the following qualifications and experience would be considered for engagement as Consultant (Finance & Accounts) and Business Development Manager (Finance & Accounts).

Minimum 2 years of experience in finance, accounts and audit matters in a senior / responsible position after acquiring the essential qualification mentioned above. <b>Desirable:</b> Relevant experience with Government Ministries and/ or PSUs

\* Competent authority reserves the right to increase or decrease the number of vacancies as may be required

**(v) Key Role & Responsibilities:**

- a. To handle matters related to Budget & Finance matters of APEDA including financial schemes
- b. To liaise with Ministry of Commerce and Industry and nodal departments and other stakeholders in these matters
- c. To organize meetings, presentations etc. as may be required from time to time
- d. Any other matter as may be assigned by the competent authority from time to time

**(vi) Submission of Application**

- a. A candidate shall submit only one application. Submission of more than one application may lead to rejection.
- b. Mere submission of the application does not confirm any right on the applicant to be called for interview.
- c. Application should be submitted strictly in the prescribed format only.
- d. The Competent Authority reserves the right to cancel any application/candidature at its discretion and no correspondence in this regard will be entertained from the applicant.
- e. Wrong declaration /submission of false information or any other action contrary to law shall lead to cancellation of the candidature at any stage.

**(vii) Age Limit**

Upper age limit of 50 years for the position of Consultant (Finance & Accounts) and 45 years for Business Development Manager (Finance & Accounts).

**(viii) Remuneration and Annual Enhancement**

The remuneration will be inclusive of all applicable taxes and no other facility or allowance will be allowed. The range of remuneration for the post is as under:

Business Development Manager (Finance & Accounts)	Rs. 70,000/-

- (ix) TA/DA:** Consultant (Finance & Accounts) and Business Development Manager (Finance & Accounts) may be required to travel to any place in India. While on tour, TA/DA will be admissible to officials at Pay Level 10 of the Central Government.

**(x) Working Hours and Leave:**

- a. Working Hours shall normally be from 9.00 AM to 5.30 PM office time during working days including half an hour lunch break in between. However, in exigencies of work, the Consultant (Finance & Accounts) and Business Development Manager (Finance & Accounts) may be required to sit late and may be required to attend office/work on Saturday/Sunday and other holidays also.
- b. The Consultant (Finance & Accounts) and Business Development Manager (Finance & Accounts) will be eligible for 20 days leave during the period of one year, on pro-rata basis subject to the prior written approval of the controlling officer. Un-availed leave cannot be carried forward to the next year.

Further, leave up to one month can be considered without remuneration with the prior approval of controlling officer.

However, in rare and exceptional cases like need for professional development, training etc.,

this condition may be relaxed with the approval of Chairman, APEDA subject to official exigencies.

- c. Apart from the above, female Consultant (Finance & Accounts) and Business Development Manager (Finance & Accounts) may be eligible for maternity leave as per the Maternity Benefit (Amendment) Act, 2017 issued by Ministry of Labour & Employment vide letter No. S-360 17/03/20 15-SS-1 dated 12th April, 2017.

**(xi) Termination:**

- a. The engagement can be terminated at any time by the Department by giving 30 days' notice or "pay in lieu" thereof. Similarly, Consultant (Finance & Accounts) and Business Development Manager (Finance & Accounts) may also resign after giving notice for a similar period.
- b. The Department reserves the right to terminate any Consultant (Finance & Accounts) and Business Development Manager (Finance & Accounts) at any stage in event of a serious failure to perform the task assigned or of failure to be serve any standards of conduct.

**(xii) General terms and conditions:**

- a. APEDA may require the Consultant (Finance & Accounts) and Business Development Manager (Finance & Accounts) to submit a Statement of Good Health from a recognized physician prior to commencement of work in any offices.
- b. The engagement as Consultant (Finance & Accounts) and Business Development Manager (Finance & Accounts) is subject to verification of documents related to educational qualification and experience. If any information / documents submitted by him/her are found false / wrong at any stage, his / her engagement will be terminated immediately and appropriate action will be taken against him / her as per rules. It is the responsibility of the candidates to provide proof in support of their claim proving any specific course as equivalent to the essential educational qualification prescribed.
- c. The Consultant (Finance & Accounts) and Business Development Manager (Finance & Accounts) will be governed by the Official Secrets Act, 1923, as amended from time to time and will not disclose to any unauthorized person(s) any information/data that come to their notice during the period of their engagement as Consultant (Finance & Accounts) and Business Development Manager (Finance & Accounts) in APEDA. All such information/records/papers/software/ emails etc. will be property of APEDA. An undertaking to that effect shall be given at the time of joining.
- d. The Consultant (Finance & Accounts) and Business Development Manager (Finance & Accounts) shall not advertise or otherwise make public for the purpose of commercial advantage that it has contractual relationship with APEDA. He / she shall not, in any manner whatsoever, use the name, emblem or official seal of APEDA or any abbreviation of the name of APEDA, in connection with business or otherwise without the prior written permission of the competent authority of APEDA.
- e. The Consultant (Finance & Accounts) and Business Development Manager (Finance & Accounts) shall be expected to conduct himself / herself in accordance with the rules and regulations of APEDA. He / she will be expected to demonstrate high moral character, integrity, secrecy of office and dedication to work while discharging his / her duties. In case his / her services are not found satisfactory or found to be in conflict with the interest of the APEDA, his/her services will be terminated forthwith, without any notice period or compensation.
- f. In general, the Consultant (Finance & Accounts) and Business Development Manager (Finance & Accounts) shall neither seek nor accept instructions from any authority external to APEDA in connection with the performance of his/her obligations under the Contract. The Consultant (Finance & Accounts) and Business Development Manager (Finance & Accounts) shall not take any action in respect of its performance of the Contract or otherwise related to its obligations under the contract that may adversely affect the interests of APEDA, and the Consultant

(Finance & Accounts) and Business Development Manager (Finance & Accounts) shall perform its obligations under the contract with the fullest regard to the interest of APEDA. The Consultant (Finance & Accounts) and Business Development Manager (Finance & Accounts) warrants that he/she has not and shall not offer any

- g. Direct or indirect benefit arising from or related to the performance of the Contract or the award thereof to any representative, official, employee or other agent of APEDA. He/she shall comply with all laws, ordinances, rules and regulations bearing upon the performance of his/her obligations under the contract. In the performance of the Contract, the Consultant (Finance & Accounts) and Business Development Manager (Finance & Accounts) shall comply with the normal standards of conduct. Failure to comply with the same is ground for termination of the Consultant (Finance & Accounts) and Business Development Manager (Finance & Accounts) for cause.
- h. **Prohibition of Sexual Exploitation and Abuse:** In the performance of the Contract, the Consultant (Finance & Accounts) and Business Development Manager (Finance & Accounts) shall comply with the "Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013". The Consultant (Finance & Accounts) and Business Development Manager (Finance & Accounts) acknowledges and agrees that any breach of any of the provisions hereof shall constitute a breach of an essential term of the contract, and, in addition to any other legal rights or remedies available to any person, shall give rise to grounds for termination of the contract. In addition, nothing herein shall limit the right of APEDA to refer any alleged breach of the foregoing standards of conduct to the relevant national authorities for appropriate legal action.
- i. In the unfortunate event of the death, injury or illness while serving APEDA, the Consultant (Finance & Accounts) and Business Development Manager (Finance & Accounts) or the next of kin shall not be entitled to any compensation or Appointment.
- j. The Consultant (Finance & Accounts) and Business Development Manager (Finance & Accounts) will be required to submit a police verification report from their concerned police station and also submit a medical- cum-fitness certificate issued by any authorized Medical Practitioner prior to engagement.
- k. The period of engagement would commence from the date of joining at APEDA.
- l. The period of engagement as Consultant (Finance & Accounts) and Business Development Manager (Finance & Accounts) will not confer any claim or right for subsequent engagement / employment with APEDA or any other Government Department at a later date.
